Based on recent changes in the French Legislation regarding the General Assemblies of French Associations, CIGRE must now hold an annual Ordinary General Assembly in the first half of the year to approve the accounts of the previous year, instead of every two years during the Session.

The Article 7 of the CIGRE Statutes was amended accordingly and now states that an Ordinary General Assembly of CIGRE Members will be called at least once a year.
It may take place by correspondence and may be undertaken electronically, or by other conventional or modern means.

- Approval of the 2016 Accounts.
- Allocation of the 2015-2016 Result.

The two resolutions are grouped on the electronic voting form.
